- Only short-listed candidates will be called for appearing in the interview which will be intimated by email or phone on or before two days prior to the Interview.
- At the time of interview, the candidates have to submit a copy of their BIODATA as per the given format, one set of hard copies of all relevant documents (self-attested). They shall have to produce all the original documents for verification at the time of interview. The candidates shall have to deposit an application fee of Rs. 100.00 (Rupees One Hundred) only for General Category and Rs. 50.00 (Rupees Fifty) only for SC/ST Category in the Bank A/C of Registrar, AVFU (A/C No. 44748518425; IFSC: SBIN0009945) of SBI, Khanapara and submit the evidence at the time of interview.
- Age Limit: the age of candidate should not be less than 21 years and more than 38 years on 1st January of 2026. The age is relaxable in case of SC/ST candidates as per the applicable rules.
